WAM open 2012 participation conditions incl. ACF^X Conference

The following are entitled to participate: architects, interior architects, landscape architects, planners, sponsors and media partners.

Categories

Disciplines: Giant slalom and parallel slalom

There are single and team rankings in both disciplines.

In the giant slalom, there is one run for each participant; the fastest run wins.

In the parallel slalom, there are two runs for each participant; one with blue markers and one with red markers.

Single event

Men and women shall be assessed separately.

Ski and snowboard runs shall be assessed separately.

Team event

The four fastest times of each declared team (ski and snowboard) shall be added. The team with the fastest overall time shall win the team event. A team can consist of a maximum of 6 persons.

Disclaimer

The organiser is entitled to impose changes to the execution of the event or to cancel it in the event of adverse weather conditions or any force majeure conditions, or in response to official orders or for safety reasons. In such cases there will be no valid claim for damages or any valid claim for reduction or reimbursement of the fee paid. This excludes any claims imposed on the organiser by the participant for property or pecuniary damages of any kind during or in connection with the event as a result of behaviour on the part of organiser, his representatives and his aides, regardless of the legal nature of the claim, as long as the damage was not caused by the organiser, his representatives or his aides intentionally or out of gross negligence.

It also excludes any liability imposed on the organiser in connection with death or physical harm or damage to health during or in connection with the event as a result of behaviour on the part of organiser, his representatives and his aides, as long as the damage was not caused by the organiser, his representatives or his aides intentionally or out of gross negligence.

If the organiser's liability is excluded or limited, then this shall also apply to the personal liability of his employees, representatives, aides and sponsors.

As long as the organiser and his employees, representatives, aides and sponsors have not been accused of intentional breach of duty, the compensation limit shall be limited to the merits and the amount of the foreseeable and typical damage.

Each signing participant is obligated to register only such persons who have been informed of the above disclaimer and limitation of liability and consented to it.

Each participant is advised to provide sufficient health, accident and liability and insurance coverage. Each participant shall participate in the event at his/her own risk - as far as this is concerned, each is cautioned to wear a helmet. A medical team shall be in place during the race.

Collection and use of data and images

The personal data submitted by the participant shall be used only for the purpose of the contract; and it shall be saved, processed and used to the extent required for processing the application and implementation of the event. It shall also be further distributed to the event sponsors listed on the website www.wam-open.com, under „Sponsors“. Furthermore, ap35 reserves the right to send its own information, notes and invitations to the participants at any point in the future. As such, the processing and use of this data is subject its given sponsor's data protection regulations. The participant consents to this during his registration.

The participant further agrees that the photos and film clips created in relation to his participation in the event were published with no pending due WAM open-related remuneration (this includes future events). This also applies for the resubmission of such personal data recognised in connection with this publication (the results lists in particular). The participant may at any time object to the resubmission of personal data to the sponsors and to the use by ap35 and publication of the photos and film clips created in connection with his participation.

Prices and booking amounts

Registration

A registration shall count as legally binding after the filling-in and submission of the registration form or pending an order using the TIXOO AG system on the Internet. An invoice shall be issued immediately. For a guaranteed attendance, the invoice must be submitted to the personal accreditation department at the WAM open 2012 or the ACF^x Conference. It is possible to pay in cash at the site of the event.

If no payment is forthcoming, the participant can be refused entry to the WAM open 2012 event.

Cancellation terms and conditions

More than 6 weeks prior to the commencement of the event on the 2nd of February 2012: free.

6 weeks prior to the commencement of the event on the 2nd of February 2012: 75% of the invoice amount.

4 weeks and less prior to the commencement of the event on the 2nd of February 2012: 100% of the invoice amount.

Jurisdiction

As long as the participant has not committed a criminal offence or his normal jurisdiction lies outside the Federal Republic of Germany, the organiser's jurisdiction headquarters is Ulm, Donau.

The valid law is that of the Federal Republic of Germany.

Severability clauses

If one or more of the above provisions should be ineffective or unenforceable, than this shall not affect the validity of the remaining clauses. The law shall apply in place of the ineffective / unenforceable provision(s). If there is no such legislation, then standard regulations shall apply.

The parties shall replace the ineffective clause with one which represents the existing economical interests of the contractual parties as closely to the original as possible without conflicting with the other clauses.
